**REQUEST FOR DRIVING SAFETY COURSE**

I, the defendant in the above styled and numbered cause, plead **No Contest** to the alleged offense.

**I state under oath that:**

- I hereby request the court to defer proceedings in this case for a period of ninety days to allow me to complete a driving safety course or motorcycle operator training course and **present a Uniform Certificate of Driving Safety Course Completion or a verification of course completion of a motorcycle operator training course;**
- I am not in the process of taking a driving safety course or motorcycle course under section 143(A) (a) (2) of the Uniform Act nor have I completed a course under that subdivision that is not yet reflected on my driving record as maintained by the Texas Department of Public Safety;
- I have a valid Texas Driver's License, or permit, not a commercial driver's license;
- I have proof of valid financial responsibility with my name on the policy (vehicle liability insurance);
- I will provide the court my driving record from the Texas Department of Public Safety which shows that I have not completed a driving safety course within the 12 months preceding the date of this offense;
- I will pay court costs and an administrative fee to the court. \$109.00 or \$134.00 in school zone.

**Both the certificate of course completion and certified driving record MUST be filed in the municipal court on or before \_\_\_\_\_.** **NO EXTENSIONS ALLOWED.**

**I understand that:**

- If I provide proof that I successfully completed a driving safety course or a motorcycle operator training course and my certified driving record, the charge will be dismissed. The court will report to the Department of Public Safety the completion date of the course taken for inclusion on my driving record.
- If I fail to present this court proof of completion of the driving safety course or motorcycle course and certified driving record, the court will impose the maximum fine and a record of the conviction will be sent to the Texas Department of Public Safety.
- **A conviction of an offense under a traffic law of this state may result on the assessment on my driver's license of a surcharge under the Driver Responsibility Program.**
- **Insufficient requests will be denied.** If not making this request in person, this form must be signed before a Notary Public.
